Repeated violations may result in expulsion. Safe flying protects the pilot, other club members and guests, and the reputation of Central Mississippi Light Flyers.

The members thanked David Mann, Bill Lehr, Bobby Johnson, Jeff Lundy, Bobby Johnson, and his brother Tim (the fish fryer) for the meal.

Upon a motion by Kerry Minninger, seconded by Mark Occhipinti, the members approved the minutes for the January meeting.

Jim welcomed Dr. Sam Suttle, Carlton Plunkett, Boyd's guest, and Linwood and Anita Nooe.

Members congratulated Bobby Johnson for soloing a Cessna 172 and Wes Watkins for earning his ATP.

Safety Officer Tommy Jackson presented a safety presentation concerning the recent US Airways emergency landing in the Hudson River. The members also discussed the commuter air crash near Buffalo, New York, which appears to have been due to icing. Tommy closed his presentation by reminding members of the importance of checklists, the distance between to orange cones on the runway (500 feet), and the pattern altitude (800 feet AGL, 1200 feet MSL

Mark introduced prospective member Linwood Nooe and his wife Anita. Mark, as mentor, motioned that they be accepted. Bill seconded, and all approved. Linwood thanked Dr. Suttle for helping renew his medical.

Financial report.
